Saving Money at Disney

My family and I recently traveled to Disney and spent time at 3 of the parks (Universal, Hollywood and Magic Kingdom). Frugality is a necessary way of life for us, so I did what I could to save money and wanted to share what I learned.

Food and beverages are extremely expensive in all of the parks, for instance, a small bottle of regular spring water is \$3.50. Bring a big backpack and pack food. I highly recommend jerky- beef, turkey, chicken, whatever type you like, as it is relatively inexpensive and doesn't take much to do the trick when hunger strikes. Veggie straws, trail mix, applesauce pouches, and granola bars travel well too. Pack refillable water bottles – buy a jug of spring water when you get there. There are drinking fountains throughout the parks to refill them.

Bring a portable phone charger with you (or several) because they are \$30 in the gift shops, and very few outlets around. If you or your kids are interested in Disney gear, buy it before you go, as clothing in gift shops can be \$25-\$100, especially Minnie Mouse ears – they're very popular but you can purchase them online or in stores here for less than \$10, saving you at least \$20 a pair!

5.) You might catch me ... - Playing a drum set somewhere in the area. Come see Speed Limit.







Mini-Grants Support Work With Autism Students

• 3 rd Place (tie) receiving a grant of \$100 - Pamela Kassos an Intervention Specialist at the Rich Center for Autism. Her project is a newer computer to help her students scan documents for work experience.

• 3 rd Place (tie) receiving a grant of \$100 - Teri Rauch, a teacher and soon-tobe BCBA at East Palestine City School District. She will use the grant to make a Mindfulness Walk for her students.

Money Management for Couples

Life partners need to be on the same page about money

We all know couples who fight about money. In fact, you may personally be in a relationship where finances are a source of tension. Even though retirement may be a long way off, the sooner you begin saving for that goal, the better. Those who are older may be primarily focused on retirement and the disposition of their estate. Sitting down with a financial advisor can be beneficial regardless of your age. An advisor will gather input from both parties and craft a plan to help guide your long-term financial decision-making.

#4 – Is proper paperwork in place?

For couples who plan to get married, there might be reasons to consider a pre-nuptial agreement. It spells out how assets are to be divided in case of divorce. Most importantly, it limits costs related to litigation should divorce occur, as the parties agreed in advance on how assets will be split. For older couples, making sure estate documents are in place is important. The issues are trickier in cases of blended families, as the distribution of assets can be more sensitive. In both cases, seeking proper legal guidance is important.

Seniors Can Reduce Their Tax Burden By Donating To Charity Through Their IRA

In most cases, distributions from a traditional Individual Retirement Account are taxable in the year the account owner receives them but there are some exceptions. A qualified charitable distribution is one of the few exceptions. A QCD is a nontaxable distribution made directly by the trustee of an IRA to organizations that are eligible to receive tax-deductible contributions. QCDs can't occur from Simplified Employee Pension plans and Savings Incentive Match Plan for Employees IRA.

Making a QCD can benefit the taxpayer by reducing their taxable income while they support qualifying charitable organizations of their choice. The taxpayer doesn't have to worry about meeting the standard deduction or itemizing deductions with a QCD. Financial institutions report QCDs on Form 1099-R for the calendar year the distribution occurs. There's no number or letter code on the Form 1099-R that indicates the distribution was a QCD.

QCD Guidelines

• Taxpayers who make a QCD must be at least 70½ years old on the day of the distribution. * A QCD will count toward a required minimum distribution.

• The taxpayer must have an acknowledgement of the contribution.

• The amount of the QCD can't be more than the amount of the distribution that would count as income. * Declare the QCD as income to claim the charitable contribution as a deduction.The maximum annual exclusion for QCDs is \$100,000.

- When filing a joint return, the spouse can also have a QCD and exclude up to \$100,000.

- Any QCD more than the \$100,000 exclusion limit counts as income like any other distribution. * The amount of QCD contribution limits for exclusion reduce after age 70½.

Reporting a QCD on an income tax return

• Report a QCD on Form 1040; report the full amount of the charitable distribution on the line for IRA distributions.

• On the line for the taxable amount, enter zero if the full amount was a QCD and enter "QCD" next to this line.


• See the Form 1040 instructions for additional information. Taxpayers must also file Form 8606 if the QCD came from:


• a traditional IRA and they received a distribution from the IRA during the same year, other than the QCD; or

• a Roth IRA.



The Difference Between Medicare **Supplement Insurance** And A Medicare Advantage Plan?

There are significant differences of Medicare. Many of these plans between Medicare Supplement insurance and Medicare plans Advantage plans. Both work well to help cover costs of care that Original Medicare Insurance does not cover. What will work best for you will depend on your specific situation and preferences. One size definitely does not fit all and there are numerous good options available.

Medicare supplement plans work with original Medicare Insurance. With a Medicare Supplement you do not cancel or replace your Medicare Part A or Part B coverage and you still have all your Medicare insurance benefits, rights and protections. These plans are a secondary (supplemental) insurance to original Medicare insurance and help cover costs not covered by Medicare. For example, Part B of Medicare Insurance covers outpatient services, doctor appointments and tests. Typically, Medicare pays 80% of approved costs after a deductible is met and you are left with the remaining 20%. There are no limits the 20% with only original Medicare insurance. A supplement will pay some or all those costs depending on the specific plan.

There are several different supplemental insurance plans available. These plans are required to be the same from company to company and are approved by CMS (Medicare). However, each company sets their own premiums and rate increase schedules. These plans do not include prescription drug coverage (part D), vision, dental or hearing benefits. A separate prescription plan needs to be added to the coverage to avoid potential Medicare last enrollment penalties.

Medicare Advantage Plans (Part combine Parts A, B and possibly C) D. They are administered by the individual insurance companies instead

Charity Breakfast Scheduled For Saturday, Dec. 3rd include prescription drug coverage and most have extra ancillary benefits. They typically have lower premiums and are either HMO or PPO plans. HMO plans require you to see doctors within their network or services are not covered except in an emergency. PPO plans do not require you to see in network doctors but will pay more of the costs if you do. The premiums for these plans vary from plan to plan and range from \$0.00 - \$100 or more. They typically have copays for services and a set maximum out of pocket amount for the year.

If you have a Medicare Advantage plan or a standalone prescription drug plan (Part D) with a Medicare Supplement insurance plan each year between October 15 - December 7 you have the option to review your plan and switch plans if there is a better option for your specific needs. Each of these plans vary in coverage, premium and availability based on the county you live in. If you have one of these plans it is a good idea to touch base with your local agent to see if it is still a good option for you.

Your local agent knows the plans available in your specific area better than an agent somewhere else answering the 1-800 numbers you see on TV. They can check the costs of the plans with your prescriptions and make sure your doctors are in network if you choose an Advantage plan. They can also compare plans from different companies. If you have a problem, you can contact them directly for help.

An Urgent Message From **Our Service Director** Re: "Flushable" Wipes and Multiple Service Calls

Dear Sewer User:

The city has responded recently to a number of emergency service calls from an area downstream of where you live. These service calls resulted in an abundance of "flushable" wipes being removed from the system. "FLUSHABLE" WIPES ARE NOT FLUSHABLE. They do not disintegrate the way toilet paper does, regardless of what the packaging says.

Residents should refrain from disposal of "flushable" wipes, baby wipes, gloves, towels, adult diapers, toilet scrubbing pads and other paper products into the sewer system. These materials could clog your home's sanitary lateral and plug the city's pumps and mainlines. The property owner is responsible for clogs in the lateral and may experience back up of their own sewage. However, a clogged pump or mainline could potentially

cause the back up of sewage in multiple homes.

Please do not flush "flushable" wipes, rubber gloves, paper towels, baby wipes, rags, adult diapers, toilet scrubbing pads or other paper products into the city sewer. These materials should be disposed of with your weekly trash service. Your anticipated cooperation on this matter is appreciated.

One-Of-A-Kind Handcrafted Bass Guitar Raffle To Benefit Local Breast Cancer Survivors

Eric Mangle has created a one-ofa-kind bass guitar that could be yours. Mangle, owner of Mangled Custom Guitars in Warren, has entered a Jacobite bass he crafted from scratch in the Great Guitar Build-Off, a competition that draws hundreds of guitar makers from multiple countries. A former touring musician, Mangle turned to creating custom guitars in 2016 after being diagnosed with congestive heart failure and looking for an outlet to keep him busy.

Mangle's Jacobite bass has a mahogany body and neck, a walnut fretboard, a flame maple cap top on the wings and headstock, Gotoh hardware, custom wound humbuckers and active preamp. It even has Luminlay side dots that glow in the dark so the players know where to place their fingers even on a dimly lit stage.

Mangle is raffling off the guitar with the proceeds benefiting a Trumbull

County charity called This Means War Against Breast Cancer, which helps breast cancer survivors with their lost wages and out-of-pocket medical expenses.

Since 2011, This Means War Against Breast Cancer has donated \$139,500 to breast cancer survivors from throughout Trumbull County to help them fight against a disease that affects one in eight women each year and whose average treatment can cost families anywhere between \$20,000 and \$100,000, research shows.

"I take great pleasure in helping groups raise money for their organizations," Mangle said. "I only take on the builds if the proceeds go to help people directly. If it will help me help others, I'm all in."
